5. Invitation letter dually signed with the complete address and the contact details of the Inviting person
6. Passport and valid residence permit copy of the Inviting person
7. Original latest personal bank statement of last six months with minimum balance of Rs. 1.5 lacs / per applicant dually signed and sealed by bank (mandatory)
8. Return air ticket itinerary
9. 2 documents to confirm the relationship with the inviting person (if blood relative)
10. Day to day itinerary (if the inviting person is not a blood relative)
